
SUBMISSION OF RESEARCH PROPOSALS FOR BASIC EDUCATION RESEARCH FUND

To: Schools Division Superintendents Regional Office Division Chiefs All Others Concerned

- 1. This has reference to DepEd Order No. 16, s. 2017 on the Research Management Guidelines that provides for the responsibility of the Regional Research Committee (RRC) in evaluating and approving research proposals and other related research initiatives from the Region and Schools Divisions for fund grant sourced from the Policy Research Program (PRP) Fund of the Regional Office.
- 2. In this regard, this Office calls for submission of research proposals for possible fund grant from regular employees of the Regional Office and Schools Division Offices on or before April 6, 2020.
- 3. The proposal may be submitted in hard copy to this Office, through the Policy Planning and Research Division (PPRD), or in e-copy through email pprd.region8@deped.gov.ph along with the following requirements:
 - a. Application form and endorsement of immediate supervisor of the proponent (Annex 1);
 - b. Research Proposal (Annex 2); and
 - c. Anti-plagiarism and absence of conflict of interest declaration (Annex 3).
- 4. As provided for by DO 16, s.2017, all proposals that have passed the initial review shall be forwarded by PPRD to the RRC for further evaluation and subsequently, endorsed for approval of fund grant.
- 5. Immediate dissemination of this Memorandum is desired.
