1. 

1. Pursuant to DepEd Order No. 13, s. 2019 dated 25 June 2019 re: Policy Guidelines on the Implementation of Enhanced Alternative Learning System 2.0, this Office shall conduct the **Regional Mass Training of Teachers (MTOT) for the Alternative Learning System (ALS) K to 12 Basic Education Curriculum (BEC)** from **September 29, 2019 to November 19, 2019** in **four batches** at the venues indicated in the enclosures, except for Batch 4 which will be announced later.
