

FOR ACADEMIC YEAR 2021-2022**

The Philippine-American Educational Foundation (The Fulbright Commission in the Philippines) is now accepting applications for Academic Year 2021-2022 for the Fulbright Foreign Student Program.

The Foreign Student Program is a scholarship opportunity for Filipinos to study at the graduate level (master's or doctoral studies) or pursue nondegree doctoral degree dissertation research in the United States.

The fields of study supported by this scholarship are the following:

1. Study of the United States – the study of American culture, life and society through such fields as government, education, arts and humanities, law, economics, literature, history, the multidisciplinary field of American Studies or any other humanities or social science field with significant study of the US subject matter.
2. Global Issues – Fields of study include the environment, human rights, governance and public administration, peace studies/conflict resolution/transformation, international relations and transnational issues, international economics, international business, international law, public health and STEM fields.
3. Open Grants – Fields of study not covered by the first two field categories with the exception of medicine, nursing, physical and occupational therapy, clinical psychology, medical technology, and accountancy.
