With reference to the conditional veto of the President in the FY 2019 General Appropriations Act (GAA) on the provision of transportation allowance and teaching aid vis-à-vis Special Hardship Allowance (SHA) and Cash Allowance (CA)¹ and the proscription against double compensation, this Office issues this memorandum to guide the field offices in the payment of such allowances.

Heads of the Regional and Division Finance Offices shall submit a certification attesting that ALS Mobile Teachers and DALSCs in their respective Regional/Division Offices who have received or have pending request for the payment of Special Hardship Allowance and Cash Allowance, shall no longer be entitled to transportation allowance and teaching aid. Said certification will also serve as basis for the obligation and release of funds for the payment of SHA (please use template attached). This is in agreement with the Department of Budget and Management (DBM) to ensure that there will be no double compensation.

Deadline of submission of the certification will be on 23 December 2019 (Monday).

Kindly assist this Office in explaining that these issues and challenges are transitory while the Department is in the process of adopting the new guidelines on the payment of Special Hardship Allowance and Cash Allowance, which will take effect in FY 2020.
