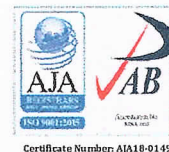

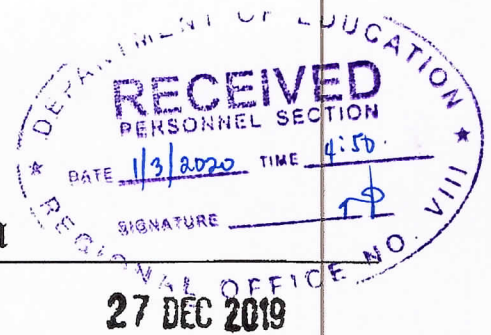

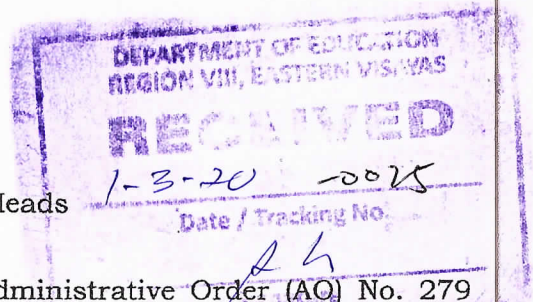

Miguel shall lead the Board Secretariat, whose functions will continue to be performed by the **Employee Account Management Division**, and perform other functions as determined by the Board, such as, but not limited to, assisting the Board in the preparation and conduct of its meetings, providing legal advice and legal assistance to the Board, and ensuring the completeness and correctness of Board resolutions and other documentations necessary for the management of the DepEd PF.
