### ADMINISTRATIVE NOTE

### **EXPECTATION**

The National Consultation on the draft DepEd Order on the Guidelines on Acquisition, Survey, and Titling of School Sites will be a discussion on the different issues and procedures and the DepEd offices involved in the acquisition of public school sites. Thus, all participants are expected to provide inputs, comments, and recommendations on the draft Guidelines on Acquisition, Survey, and Titling of School Sites. All activities, workshops, and exercises are participated in nature.

### SCHEDULE AND VENUE

The National Consultation on the draft DepEd Order on the Guidelines on Acquisition, Survey, and Titling of School Sites for Cluster II to IV will be held on the given schedule below. Participants for this cluster will come from the DepEd-Regional Office Nos. I, II, IV-B, VI, VII, VIII, IX, X, XI, XII, CAR and CARAGA.

### TRAVEL ARRANGEMENTS

Participants are requested to arrive on Day Zero, starting at 2:00 PM. The program proper will start on Day One and will end Day Two at 5:00 PM. Participants will depart from the venue after the culmination of the Day Two activity or the next day.
