The nominations must be duly signed by the chairperson of the PRAISE Committee or its equivalent and the Secretary shall approve/recommend the nomination.

The accomplished forms must be submitted together with the complete set of nomination documents to the Department of Education (DepEd) PRAISE Committee through the **Employee Welfare Division (EWD), DepEd Central Office** at DepEd Complex, Meralco Avenue, Pasig City not later than **March 13, 2020**. This is to give time for the PRAISE Committee to evaluate nominees before endorsing the same to the CSC by March 31, 2020.
