In consideration of the COVID-19 pandemic where areas are put in Enhanced Community Quarantine (ECQ) or General Community Quarantine (GCQ), the Department of Education (DepED) accelerated the adoption of alternative models to continuously respond to the educational needs of learners. To ensure the provision of quality assured Grade 3 Araling Panlipunan (which centers on regional content) modules to our grade 3 learners, the Bureau of Learning Delivery strongly suggests that all regions must develop their own self-learning modules using the newly developed Grade 3 Araling Panlipunan Learner's Material as the source of content and formative assessment.

As to the development of the modules, it should be consistent with the following:

- a. Follow the Alternative Delivery Mode (ADM), Learner Resource quality standards.
- Processing questions that cannot be answered by the provided content be not included in the modules
- c. Include/Develop modules with the following content (You may opt to improve, contextualize, and/or translate attached reference material in accordance to the level of the learner.):
 - a. What is epidemic?
 - b. What is pandemic?
 - c. What are the local accounts of epidemic?
 - d. What is Covid-19?
 - e. What are the symptoms of Covid-19?
 - f. What are the treatments for Covid-19?
 - g. What are the prevention methods for Covid-19?
 - h. How can you protect yourself and your family?
 - i. What will you do if you or a family member get the virus?
 - j. How did the region/divisions/barangays address the Covid-19 pandemic in your area?

During this time when uncertainty and anxiety is felt, it is essential to provide the learners, their families and the general community with easy to digest materials and helpful strategies on how they can manage learning. The situation, however challenging, presents an opportunity for learners to acquire valuable lessons and skills necessary in navigating in the 21st century, which is what education is preparing the learners for.
