

**RETRIEVAL AND REPLACEMENT OF GOVERNMENT RECOGNITION BEARING
ISO ACCREDITATION AND CERTIFICATION MARK**

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. In compliance with the ISO standards, this office through the Quality Assurance Division (QAD), advises all Private Schools in the attached list being issued with **Government Recognition Certificates** bearing ISO accreditation and certification mark to return said documents to this Office for reconsideration and replacement.
2. Per observation on the first surveillance audit since its ISO certification by AJA last July 25, 2019 it was noted that "The organization shall exercise care with property belonging to customers or external providers while it is under the organization's control or being used by the organization." Clause number 8.5.3 (**Property belonging to customers or external providers**). Findings revealed that some documents were found to be unintentionally marked with the AJA logo such as, Government Permit, Government Recognition, Plaque of Recognition, Certificate of Recognition, Certificate of Appreciation, Certificate of Appearance and other similar documents.
3. As part of the corrective action all Schools Division Superintendents of the concerned offices are directed to facilitate the return of all Government Recognition Certificates cited above effective immediately.
4. For wide dissemination and strict compliance.
