

This has reference to Memorandum Circular No. 2020-03 on the Adjustment and/or Implementation of the FY 2020 GAD Plan and Budget (GPB) in light of the Coronavirus Disease 2019 Situation (see attached) issued by the Philippine Commission on Women (PCW), which provides guidance on the revision and/or implementation of the FY 2020 GPB to implement GAD PAPs that address gender issues and concerns related to the COVID-19 situation.

Presidential Proclamation Nos. 922 and 929 declaring a State of Public Health Emergency and, consequently, a State of Calamity throughout the Philippines enjoin all government agencies "to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19."

Hence, DepEd offices at the central and regional levels are advised to review and revise, as necessary, their FY 2020 GPBs to implement measures to address gender issues and concerns arising from the unequal status of their women and men stakeholders due to the COVID-19 situation. Such measures should be in line with their respective agency mandates, Republic Act No. 9710 or the Magna Carta of Women, and the Bayanihan to Heal as One Act.

Kindly submit the revised FY 2020 GPBs to the GAD Focal Point System (GFPS) Central Office (CO) Secretariat at depedco.gfps@gmail.com. Deadline for submission is on 19 June 2020. This is to give ample time for review and consolidation by the CO.
