Relative to the transportation concerns due to the sudden change of National Schools Press Conference (NSPC) and the National Festival of Talents (NFOT) schedule of activities in consideration to the declaration of lockdown and community quarantine by the national and local government, all transportation expenses pertaining to NSPC and NFOT of DepEd public school learners and employees – whose forfeited/non-refundable tickets for the original and rescheduled dates of the NSPC and NFOT that are originally charged against their unit's regular allocation for maintenance and other operating expenses (MOOE)— can be charged against local funds subject to availability, and usual budgeting, accounting and auditing rules and regulations.
