RENAMING OF JOHN PAUL SEMINARY HOUSE OF FORMATION TO JOHN PAUL SEMINARY OF THE DIOCESE OF CATARMAN INC.

- 1. In reference to the Amended Articles of Incorporation approved by the Securities and Exchange Commission (SEC) and request for the renaming of school by the Rector, the Department of Education Regional Office No. VIII through the Quality Assurance Division (QAD) announces the change of the name of the school from John Paul Seminary House of Formation to John Paul Seminary of the Diocese of Catarman Inc., effective August 10, 2020.
- 2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage by the residents of the community, be placed beneath the new name as follows:

JOHN PAUL SEMINARY OF THE DIOCESE OF CATARMAN INC.

(Formerly John Paul Seminary House of Formation)

- 3. The change of name does not instill any deviations on the provisions of the Government Permit (GP) given to the said school. Thus, Government Permit No. 104, s. 2016 for Senior High School, still remain legal and official.
- 4. Copies of this issuance shall be posted at the Regional Office, Division Offices, Municipality/City Halls, Schools, and other conspicuous places for reference and information of the general public
- 5. The Schools Division Superintendent of Northern Samar Division is advised to facilitate the updating of data and profile of the aforementioned school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and to monitor the implementation of this issuance.
