



C. SELECTION PROCESS

- The Board of Judges shall decide who among the winners of the three (3) categories will be the national winner.
- Finalists may be requested to personally or virtually appear before the Board of audges to make a presentation or for interview.
- Special Citations may also be awarded by the Board of Judges.
- The decisions of the Board of Judges shall be final.

Rationale

Entrepreneurs play a significant role in the country's development as vital contributors to economic growth and prosperity. With their innovative ideas and business acumen, entrepreneurs develop new products and markets, create wealth and generate jobs. Their role is crucial for the country as it participates in a highly competitive global economy.

Recognizing the invaluable role of entrepreneurs in nation-building, the Philippine Chamber of Commerce and Industry (PCCI) will again confer the Injap Sia Outstanding Young Entrepreneur Awards during the 46th Philippine Business Conference (PBC) to highlight the exceptional talents and contributions of young entrepreneurs in nation-building. This Award is a celebration of youth entrepreneurship, by people who will likely become our captains of industry in our next generation. By promoting successful young role models, PCCI hopes to further motivate existing and emerging entrepreneurs.

Award Categories

Outstanding Young Entrepreneur in:

o Agriculture o Industry o Services

PCCI will select the PCCI Injap Sio Oustanding Young Entrepreneur from the winners of the above categories.

Eligibility

The nominee must:

- be Filipino, male or female, 45 years old or younger at the time of nomination;
- has established or founded his/her own business with demonstrated success and unique marketing or production approach or a combination of both shown in company's/ enterprises' products/services; or a significant shareholder or a management member of the company/enterprise that have initiated or introduced innovations in the company
- demonstrated leadership in the locality/ies where the business operates

The nominee's company or enterprise must

- be incorporated / registered in the Philippines and has been operating for a minimum of two (2) years);
- has complied with basic government requirements (BIR, SEC, DTI, Business / Mayors Permit, SSS, etc.);
- · has shown profitability in the last two years.

A. AWARDS CRITERIA

In keeping with the theme of this year's 46th Philippine Business Conference & Expo (PBC&E), Innovation Nation, the applicants will be assessed based on the following criteria:

The nominee created, nurtured and developed new products, services or markets. Achievements can include, but not limited to the invention, design, production, performance, marketing and distribution of their product or service.

The nominee was able to play a significant role in the implementation and effective delivery of a highly innovative idea. The outstanding innovation must have direct and indirect impact in specific area of function critical to the business (i.e production, marketing, finance, human resource, management and innovation (research and development).

B. NOMINATION RULES

- 1. The PCCI Injap Sia Outstanding Young Entrepreneurship Awards is open to all Filipino citizens who were born not earlier than January 1, 1975. The nominee must also be the owner/ founder or a significant shareholder or a management member of a Philippine-registered / incorporated enterprise that has been operating for a minimum of two (2) years.
- 2. All member companies of PCCI and its local chambers, business councils, trade and industry associations can nominate candidates for the PCCI Injap Sia Outstanding Young Entrepreneur Awards.
- 3.Other business organizations, industry and trade associations and civic organizations, may also nominate candidates for the award. Partner government agencies such as Department of Trade and Industry (DTI) and Department of Science and Technology (DOST) may also nominate.
- 4. Young entrepreneurs can likewise directly apply for the award by submitting the completed nomination form to the awards committee with the endorsement from associations affiliated with PCCI or from government agencies.
- The timeframe of achievement that will be considered will be for two years covering the period January 1, 2018- December 31, 2019.
