**REGIONAL VIRTUAL CAPACITY BUILDING ON THE IMPLEMENTATION OF THE
HOMEROOM GUIDANCE PROGRAM**

To: Schools Division Superintendents
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD) will conduct the Regional Virtual Capacity Building on the Implementation of the Homeroom Guidance Program via Zoom on September 2, 2020, at 9:00 AM-3:00 PM.
2. The activity aims to:
 - a. discuss the Rationale, Brief History, Philosophy, Vision and Mission, and Curriculum Framework of the Guidance Program;
 - b. enhance the knowledge and understanding on the policy, procedures, assessment, and learning materials that are involved in the implementation of the Guidance Program;
 - c. orient the concerned participants on the Most Essential Learning Competencies (MELCs) and Self-Directed Learning in Homeroom Guidance; and
 - d. enhance the skills of the Guidance Counselors/Designates/Advocates on the effective delivery of instructional strategies in the utilization of the learning modules.
3. The participants to this activity are the Regional and Division Edukasyon sa Pagpapakatao Supervisors and Guidance Counselors/Designates/Advocates of the 13 Schools Divisions.
4. All Learning Facilitators are directed to attend a planning meeting, orientation, and training dry run via Google Meet on August 28, 2020. The meeting link shall be shared through email/Facebook messenger.
5. The SDOs shall send to this Office the list of participants using the attached confirmation letter template (Enclosure B) duly signed by the Schools Division Superintendent to clmd.region8@deped.gov.ph not later than August 28, 2020.
6. The Division trainers are expected to conduct the same training to the Public Schools District Supervisors and teacher-representatives per school after the activity.



7. The trained teacher-participants shall serve as Guidance Advocates who shall conduct Learning Action Cell (LAC) sessions in any available platform following the established health protocols and using the guides and video lessons provided by the Central Office. An Activity Completion Report on the conduct of Division-wide training shall be submitted not later than October 5, 2020, to clmd.region8@deped.gov.ph.
8. The participants are advised to adhere to the guidelines corresponding to the Risk Severity Classification of their respective areas as set by the Inter-Agency Task Force – Emerging Infectious Diseases (IATF-EID). They may attend the activity while working from home or at school.
9. A Certificate of Participation shall be given to the participants upon completion of the one-day activity.

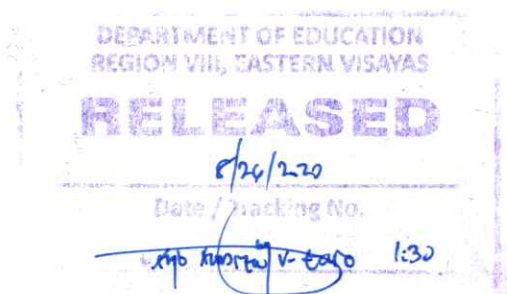
