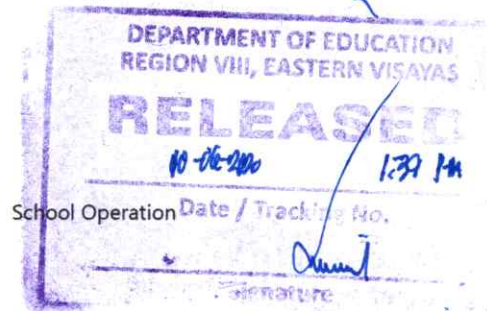
**CLOSURE OF LADY HEART LEARNING CENTER, INC.

Niño, Alangalang, Leyte Division, Regional Office VIII with School ID No. **451516**, effective SY. 2020-2021. The closure of the School is through voluntary withdrawal of Permit under section 34 of DepEd Order No. 88, s. 2010 per communication received from **Ms. Corazon S. Ramos**, Principal and endorsed by the Schools Division Superintendent of Leyte Division. Said school has been greatly affected by the escalating health crisis brought about by the novel corona virus and that the school head decided to temporarily close the school.
