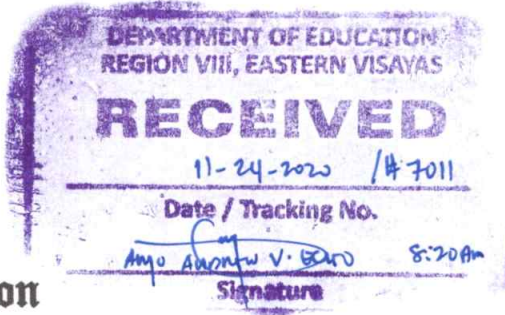




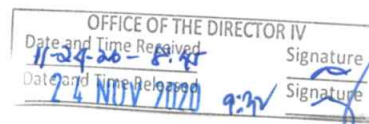

SUBJECT : SUBMISSION OF REPORT ON THE RELEASE AND RECEIPT OF  
FY2020 OPERATION OF SCHOOLS-MOOE FUNDS IN COMPLIANCE  
WITH REQUIREMENTS UNDER ADB LOAN AGREEMENT FOR  
SECONDARY EDUCATION SUPPORT PROGRAM (SESP)

This refers to DepEd's compliance with the loan covenant under the Three Hundred Million Dollars (USD 300M) financing from Asian Development Bank to the Government of the Philippines, with the Department of Education as the Program Executing Agency for the **Secondary Education Support Program for the period 2019-2023**. This program is aimed at improving secondary level learning outcomes and completion rate.

SESP Program Components include:

- Improvement of the quality of secondary program through the provision of support to strengthen the secondary curriculum and assessment system;
- Improvement of the quality of the secondary education teachers; and
- Strengthen secondary education sector management by supporting reforms to ensure that secondary schools received their budgets for MOOE on time.**

**Disbursement Link Indicator (DLI).** As part of the loan covenant, DepEd shall cause to perform or achieve DLIs. These are broken down into sequence of time bound targets. These DLIs are sub-components whose achievement triggers the disbursement of funding from ADB to the Government of the Philippines.

**DLI No. 5 is Secondary education financing system strengthened.** One of the sub-DLIs particularly **DLI 5.2 should be achieved in FY 2020** to wit: **At least 50% of DepEd secondary schools as of December 31, 2018 receive their school MOOE on time.** This DLI is achieved when at least 50% of DepEd SSSs receive their school MOOE budget on time.

**Reportorial Requirements.** To enable DepEd to comply and achieve DLI 5.2, all concerned are directed to submit the reports using the attached three (3) templates which may be filled out via google drive. These templates will capture the data from the Implementing Units (IUs) and Non-Implementing Units (Non-IUs). Please inform the Finance Service-Budget Division, DepEd Central Office **on or before November 28, 2020 on the submitted reports. All ROs shall submit a signed (e-signature accepted) consolidated report based on the submission of the SDOs. The SDOs shall ensure all IUs and Non-IUs are covered by the report.**
