The closure of the school is through voluntary withdrawal of Permit under section 43 of DepEd Order No. 88, s. 2010 per communication received from Victor A. 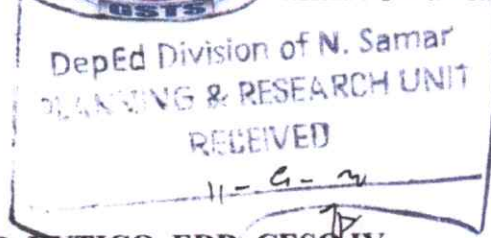

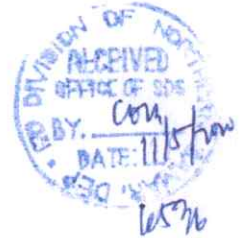

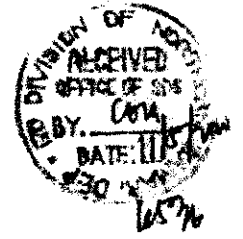
