Subject: **IMPLEMENTING GUIDELINES ON THE ALLOCATION, UTILIZATION, DOCUMENTATION, AND REPORTING OF PROGRAM SUPPORT FUNDS FOR THE IMPLEMENTATION OF YOUTH FORMATION PROGRAMS**



The Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD) is mandated to empower Filipino children and youth who are responsible, hardworking, enterprising, persevering, value-driven, culturally rooted, equipped with world class skills, and imbued with values such as *Maka-Diyos, Maka-Tao, Maka-Kalikasan, and Maka-Bansa*.

In this regard, program support funds are provided to enable the regions and divisions to conduct various activities relating to Youth Formation.

The Department of Education (DepEd) issues the **Implementing Guidelines on the Allocation, Utilization, Documentation, and Reporting of Program Support Funds for the Implementation of Youth Formation Programs**.

This defines the processes and reportorial requirements to ensure the proper, efficient, and effective utilization of the program support funds for youth programs and activities of regions and divisions for Fiscal Year (FY) 2020.

Annex A

General Guidelines

1. Regions and Divisions shall receive FY2020 Program Support Funds for the implementation of Youth Formation Programs. Funds are released through Sub-Allotment Release Order (Sub-ARO) from the Central Office to the Regional Offices (RO).

The ROs shall issue a Sub-Allotment Release Order (Sub-ARO) to divisions corresponding to the allocation provided in Annex 1 (Allocation list per Region and Division). Coordination with region and division budget and accounting offices is advised.

2. Programs

- A. Planning, Monitoring, and Evaluation of Youth Formation Programs (YFP)
 - a. Implementation of but not limited to Student Government Program and Youth Environment in Schools (e.g., School Inside a Garden (SIGA), Gulayan sa Paaralan (GPP) and Youth Disaster Readiness Development Program (YDRDP).
 - b. Region, division and school Youth Formation Programs evaluation and planning activities; and
 - c. Monitoring visits on YFP implementation in the schools.
- B. Youth Formation Initiatives and Capacity Building in the New Normal
 - a. Implementation of Youth Formation related programs, projects and activities identified and initiated by divisions or regions for FY2020; and
 - b. Trainings and capacity building activities for YFD coordinators in divisions and schools when allowed by the local required health standards.

3. Allowable Expenses

1. Supplies and materials but not limited to purchase of technology-related devices (e.g., headset, mobile wifi);
2. Reproduction of materials;
3. Travel expenses related to the following activities, pursuant to Executive Order No. 77, s. 2019 (Prescribing Rules and Regulations and Rates of Expenses and Allowances for Official Local and Foreign Travels of Government Personnel) and DepEd Order No. 22, s. 2019 (Guidelines on Official Local Travels in the Department of Education) and allowed by the local required health standards:
 - a. Planning, monitoring and evaluation of YFP implementation in schools conducted by YFD coordinators; and
 - b. Quarterly meetings and school visits of YFD coordinators.
4. Communication allowance of up to P1,000.00 per Youth Coordinator (PDO1) per month;
5. Honorarium for resource speakers based on the guidelines set by the Department of Budget and Management (DBM); and



6. Contingency to cover payment of miscellaneous expenses incidental to the conduct of activities, such as, gasoline, and other Maintenance and Other Operating Expenses (MOOE) expenses per Government Accounting Manual (GAM) Volume III.
4. Regions and Divisions may conduct Youth Formation Program activities at regional or division level. This will be based on the assessment and strategy of regional and division YFP Coordinators to ensure the efficiency of the conduct of the activity. Augmentation from other fund sources is encouraged to cover other expenses, if necessary.

All expenses shall be subject to the usual budgeting, accounting, auditing and procurement rules and regulations. Misuse and/or mismanagement of these funds for the purpose other than those authorized in this guideline is strictly prohibited. Any violation committed by any individual or group will be dealt with in accordance with existing government accounting and auditing rules and regulations.

5. Judicious utilization of the fund is expected. Obligation, implementation, and payment shall be compliant to Executive Order (EO) No. 91, entitled "Adopting the Cash Budgeting System Beginning Fiscal Year 2019, and for Other Purposes.
6. Responsibilities
 - A. The Region and Division YFP coordinators may utilize the funds either through any mode of payment whichever is applicable – direct payment, cash advance, or through reimbursement;
 - B. The Region and Division YFP Coordinators in coordination with Region and Division Finance Officers shall be accountable for the disbursement and liquidation of funds support/downloaded to their respective offices;
 - C. Monitoring tools for the funds downloaded is provided as Annex 2. The Division YFD Coordinators shall submit the report to the concerned Regional YFD Coordinator for consolidation and submit to BLSS-YFD at blss.yfd@deped.gov.ph and shall be supported with photo documentations; and Region and Division YFD Coordinators are directed to compile all original copies of the signed reports;
 - D. Obligation and disbursement of funds shall be in accordance with applicable DepEd, COA and DBM guidelines.
7. Monitoring and Evaluation

The Central Office, through the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD) shall conduct regular monitoring of program implementation/fund utilization of RO and SDO.
8. Effectivity

These guidelines shall take effect upon its approval.
