  - c. embedding the unique interventions and significant experiences gained during the Monitoring, Evaluation, Accountability, and Learning (MEAL) activities.
3. The Schools Division Superintendents are requested to submit the electronic copy of the revised or supplemental BE-LCPs at [oard.region8@deped.gov.ph](mailto:oard.region8@deped.gov.ph) on or before December 10, 2020.
4. To achieve harmony and alignment of all the concerted efforts, the SDOs are expected to ensure that the schools within their jurisdictions shall likewise come up with their revised or supplemental BE-LCPs.



- Conduct virtual monitoring and evaluation/online survey to SDOs on the adoption of the learning delivery options such as Distance and Blended Learning Modality e.g. Self-Learning Modules with Online Distance Learning as well as TV/Radio-Based Instruction, online/offline and/or recorded lectures and other learning modality/ties most suitable to the learners, learning context, and other factors to be considered affecting successful learning.

### **Education Support Services**

- Provide technical assistance to SDOs on forging partnerships with LGUs and other partners in the provision of handwashing facilities, COVID-19 preventive equipment, materials for the study from home program, and other financial and /or any support for the operationalization of the distance modular learning modality with other enhancements e.g. TV/RBI, audio/video lectures, online platforms for online distance learning

### **Information and Communication Technology**

- Monitor SDO's quarterly report on Schools' Internet connectivity through the MEA

### **Finance Services**

- Monitor the submission of Statement of Expenditures (SOE) on the utilization of the BE-LCP funds
