MIND S-COOL PROJECT OF THE BONIFACIO ART FOUNDATION INC.

The Bonifacio Art Foundation Inc. (BAFI) offers Mind S-Cool (MSC), a project borne out of the COVID-19 Pandemic. It aims to empower the learner-viewers to discover their own minds in learning in connected ways across topics, essentially bridging the sciences and the arts for its viewers, and to connect science and art to other things happening in the real world and how learners could help make the world better, in the new normal, knowing those connections.

The MSC has two distinct but connected channels mentioned below.

 Mind S-Cool TV is a weekly series of 30-minute episodes aired on Colours and One PH channel on Cignal TV. The episodes follow the general curriculum, and connect in to the larger realities in the world.

2. MIND S-COOL Online is an educational web series of 10 15-20 minute videos per season. In each lesson, resident scientists delve into K to 12 science concepts based on the DepEd K to 12 Curriculum and also explore art topics through hands-on projects, interviews with special guests, and tutorials. The seasons follow the DepEd Science Curriculum partnered with themes from Art topics and concepts.

Season 1: Matter + Visual Arts

Season 2: Life and the Environment + Art in Nature

Season 3: Force, Motion and Energy + the Performing Arts

Season 4: Earth and Space + Experiments in Art

Videos will be made available on schedule. Mind S-Cool Online subscription also provides access to quizzes, worksheets, and recommended resources to further students' learning. While this is a paid subscription, BAFI also works with partners to subsidize the subscription of public schools.

The MSC is targeted at K to 12 learners with access to television and/or the internet, as well as teachers, parents, and guardians looking for educational tools that will aid them and their learners or children in adapting to the new modes of learning delivery.
