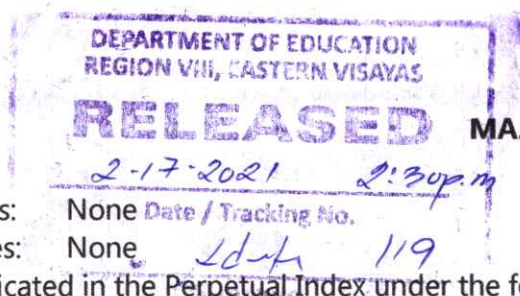
**RENAMING OF BARIBADON PRIMARY SCHOOL TO

1.
