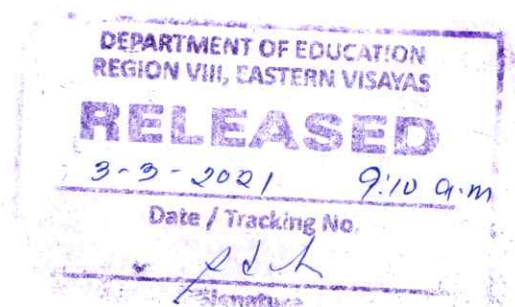


The celebration is a timely response to the President's concern over the 4,200+ cases of violence against women and their children committed over three (3) months since community quarantine was implemented.
