**ORIENTATION ON THE BASIC EDUCATION DATA BANK  
AT THE DEPARTMENT OF EDUCATION REGION VIII**

1. Pursuant to Policy, Planning, and Research Division's (PPRD) mandate as the Division responsible in managing data going in and out of DepEd, this Office shall conduct an orientation on the mechanisms of the Basic Education Data Bank (BEDB) in DepEd Region VIII on March 19, 2021, Friday at the RELC NEAP-VIII for Regional Office (RO) participants and via Google Meet for Schools Division Offices' (SDO) participants.
2. This activity aims to enhance the technical data management capabilities of data managers on the mechanisms of the data bank, to further ensure fast and reliable collection and release of timely and relevant data and information from Schools, Districts, Schools Divisions, and the Region as a whole.
3. The expected participants are the 13 Planning Officers of all SDOs, the 8 RO Division Chiefs, and the Data Managers from each RO Division, Section, and Unit. The meeting link shall only be sent to the confirmed attendees.

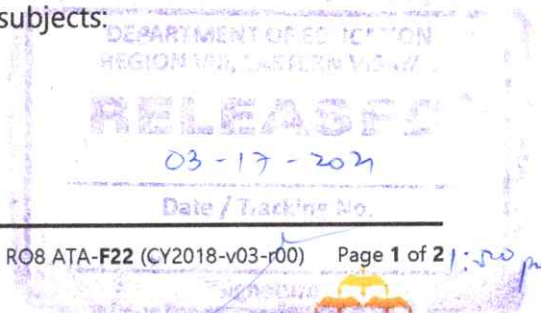
