- In reference to the recommendation from the National Historical Commission of the 1. Philippines relative to the request for the renaming of school, the Department of Education Regional Office No. 8 through the Quality Assurance Division (QAD) announces the change of name of school from Hibulangan Elementary School to Felix T. Moring Sr. Elementary School, effective May 7, 2021 in honor of the late Felix T. Moring Sr., donor of the school lot.
- 2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage by the residents of the community, be placed beneath the new name as follows:

#### FELIX T. MORING SR. ELEMENTARY SCHOOL

(Formerly Hibulangan Elementary School)

- The Schools Division Superintendent of Leyte Division is advised to facilitate the updating of data and profile of the aforementioned school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and to monitor the implementation of this issuance.





### **RESOLUTION NO. 110, S. 2020**

A RESOLUTION AMENDING RESOLUTION NO. 07, S. 2020 RELEVANT TO THE SUPPORT OF THE LOCAL GOVERNMENT OF VILLABA IN REFERENCE TO THE CHANGE OF NAME OF HIBULANGAN ELEMENTARY SCHOOL TO FELIX T. MORING, SR. ELEMENTARY SCHOOL

WHEREAS, Chapter 2. Section 13. (c), (3) of the Local Government Code of 1991 (R.A. 7160) states that "The Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of city, municipality, public elementary, secondary and vocational or technical schools";

WHEREAS, the school administrator and staff of Hibulangan Elementary School Hibulangan, Villaba, Leyte initiated a move to rename the aforesaid institution to give honor to the donor, Feix T. Moring, Sr., of the land area where this entity is located.

WHEREAS, in Item No. 4.6 of the Department Order No. 29, S. 2011, the Revised Guidelines on the Naming and Renaming of Schools, it is provided that "No public place should be named or renamed after a person within ten (10) years of his death".

WHEREAS, Felix T. Moring. Sr. died on December 22, 1995 as evidenced by his death certificate issued by the Office of the Local Civil Registrar of Villaba, Leyte on June 8, 2020 which certificate bears Registry No. 95-00146.

WHEREAS, considering that, per death certificate, Felix T. Moring, Sr. died on December 22, 1995, he is at the present time already more than ten (10) years of being dead; and

WHEREAS, the foregoing justification added to his generous donation for the welfare of the school children, teachers and parents in the community, the name of Felix T. Moring, Sr. is well enough for the above-contemplated change of school name.

WHEREFORE, on motion by the Hon. Rogelio J. Baay, chairman, SB Committee on Education, duly seconded en masse, Be it

RESOLVED, as the Sangguniang Bayan hereby resolved, that the local government of Villaba, Leyte, shall support the proposed change of name of Hibulangan Elementary School to Felix T. Moring, Sr. Elementary School.

RESOLVED, further, that copies of this resolution be furnished the concerned school Administrator of Hibulangan Elementary School and other interested parties.

MORING. SR.
