1. 2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage by the residents of the community, be placed beneath the new name as follows:

**FELIX T. MORING SR. ELEMENTARY SCHOOL**  
( Formerly Hibulangan Elementary School)

3. Copies of this issuance shall be posted at the Regional Office, Division Office, Municipality/City Halls, Schools and other conspicuous places for reference and information of the general public.

4. The Schools Division Superintendent of Leyte Division is advised to facilitate the updating of data and profile of the aforementioned school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and to monitor the implementation of this issuance.



### RESOLUTION NO. 110, S. 2020

A RESOLUTION AMENDING RESOLUTION NO. 07, S. 2020 **RELEVANT TO THE SUPPORT OF THE LOCAL GOVERNMENT OF VILLABA IN REFERENCE TO THE CHANGE OF NAME OF HIBULANGAN ELEMENTARY SCHOOL TO FELIX T. MORING, SR. ELEMENTARY SCHOOL**

**WHEREAS**, Chapter 2, Section 13, (c), (3) of the Local Government Code of 1991 (R.A. 7160) states that "The Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of city, municipality, public elementary, secondary and vocational or technical schools";

**WHEREAS**, the school administrator and staff of Hibulangan Elementary School, Hibulangan, Villaba, Leyte initiated a move to rename the aforesaid institution to give honor to the donor, Felix T. Moring, Sr., of the land area where this entity is located.

**WHEREAS**, in Item No. 4.6 of the Department Order No. 29, S. 2011, the Revised Guidelines on the Naming and Renaming of Schools, it is provided that "No public place should be named or renamed after a person within ten (10) years of his death";

**WHEREAS**, Felix T. Moring, Sr. died on December 22, 1995 as evidenced by his death certificate issued by the Office of the Local Civil Registrar of Villaba, Leyte on June 8, 2020 which certificate bears Registry No. 95-00146.

**WHEREAS**, considering that, per death certificate, Felix T. Moring, Sr. died on December 22, 1995, he is at the present time already more than ten (10) years of being dead; and


**WHEREAS**, the foregoing justification added to his generous donation for the welfare of the school children, teachers and parents in the community, the name of Felix T. Moring, Sr. is well enough for the above-contemplated change of school name.

That we hereby affirm that we have executed this instrument out of our own free will without force, intimidation or violence upon our person, and that we have hereby received our just and proper share and have no more claim or demand against each other in connection with the adjudication of the above-described parcel of land.
5. That further, for and in consideration of our love and affection for the people of Brgy. Hibulungan, Villaba, Leyte, we unanimously, absolutely and freely GIVE, TRANSFER and CONVEY by way of DONATION the above-described property unto HIBULANGAN ELEMENTARY SCHOOL, represented herein by its Principal, MARITA M. VIAGEDOR, of legal age, married, Filipino and a resident of Plaridel St., Poblacion del Norte, Villaba, Leyte (hereafter, the "DONEE"), and the latter is ready, willing and able to accept the same; Provided, that the DONEE agrees that the purpose of the donation is for the construction and establishment of a school and that, after the approval/certification by the Historical Commission and approval by the appropriate government agency/ies, the school will be named after **FELIX T. MORING, SR.**
