DOWNLOADING AND UTILIZATION OF EARLY LANGUAGE LITERACY AND NUMERACY (ELLN) COMPREHENSIVE RELEASE FUNDS TO SCHOOLS DIVISION OFFICES

To: Schools Division Superintendents
All Others Concerned

1. In line with the implementation of the Early Language Literacy and Numeracy (ELLN) and as a support to DepEd Memorandum No. 173, s. 2019 "Hamon: Bawat Bata Bumabasa", this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download the ELLN Comprehensive Release Funds amounting to **Forty-four Thousand Four Hundred Sixty-one Pesos (Php44,461.00)** per Schools Division Office.
2. The program support funds shall be used to cover the eligible expenses relative to the conduct of the online region-wide and / or division-wide training of untrained Education Program Supervisors of the Regional Offices (ROs) and Schools Division Offices (SDOs), Public Schools District Supervisors, school heads and one (1) select teacher for any of the ELLN related training programs: 10-Day Basic Training on ELLN, Training on the Adoption of the Blended Delivery Model for TPD: Roll Out of ELLN Digital, Training on Literacy Instruction, Developmentally Appropriate Practices (DAP) in ELLN and Kindergarten Training.
3. The Schools Division Offices, through the Chiefs of the Curriculum and Implementation Division, are required to come up with an implementation plan for the conduct of the School-based Learning Action Cell (SLAC) sessions and submit an Activity Completion Report (ACR) which includes the Utilization of the downloaded Funds not later that December 10, 2021 to clmd.region8@deped.gov.ph cc dandyacuina@deped.gov.ph.
4. Immediate dissemination of and compliance with this Memorandum are desired.

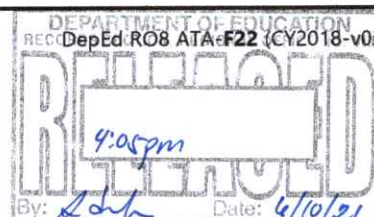

PROGRAM SUPPORT FUNDS FOR FY 2021**

In line with the implementation of the ELLN Program, each region is allotted a Program Support Fund for FY 2021 amounting to **Five Hundred Seventy-Eight Thousand Pesos (Php578,000.00)** which shall be directly released to the regions.

The program support funds shall be used to cover the eligible expenses relative to the conduct of the online region-wide and/or division-wide training of untrained Education Program Supervisors of the regional offices (ROs) and schools division offices (SDOs), Public Schools District Supervisors, school heads and one (1) select teacher for any of the ELLN related training programs: 10-day Basic Training on ELLN, Training on the Adoption of the Blended Delivery Model for TPD: Roll Out of ELLN Digital, Training on Literacy Instruction, Developmentally Appropriate Practices (DAP) in ELLN and Kindergarten Training. These activities are in support to DepEd Memorandum No. 173, s. 2019 or Hamon: Bawat Bata Bumabasa (3Bs Initiative). Schools Division Offices are required to come up with an implementation plan for the conduct of the school-based Learning Action Cell (LAC) sessions.

The following are the eligible expenses relative to the conduct of the online training: training material/kits, supplies and reimbursement of communication expense for online training as provided for in DepEd Order No. 40, s. 2020.
