In support of the Alternative Learning System (ALS) Expansion Program of the Department of Education and in order to strengthen the online strategies that shall enhance the current distance learning modalities, this Office, in partnership with the Bureau of Jail Management and Penology Regional Office VIII (BJMP RO VIII), hereby announces the **Virtual Training for the Jail Officers in Region VIII on Managing the Alternative Learning System (ALS) Sessions to the Persons Deprived of Liberty (PDLs) through a Modified Radio-Based Instruction (mRBI) Approach on June 15-17, 2021 via Google Meet.**

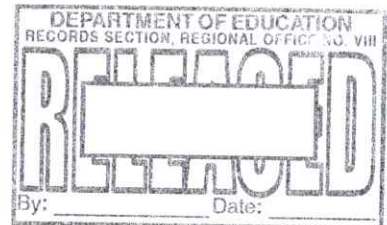
