

SEMINAR-WORKSHOP ON RESEARCH FOR SUPERVISORS, SPECIALISTS, AND MEMBERS OF THE REGIONAL AND DIVISION RESEARCH COMMITTEES

To: Schools Division Superintendents
Functional Division Chiefs
All Others Concerned

- 1. This Office, through the Policy, Planning, and Research Division (PPRD), shall conduct a two-day virtual Seminar-Workshop on Research for Supervisors, Specialists, and Members of the Regional and Division Research Committees on July 8-9, 2021 via MS Teams.
- 2. The objectives of the seminar-workshop are as follows:
 - a. orient/reorient the participants on policy formation and research management in DepEd;
 - b. provide insights on data-gathering and analysis methods in the new normal;
 and
 - c. provide technical assistance on the writing and evaluation of research paper.
- 3. The participants are all the Public Schools District Supervisors (PSDSs), regional and division Education Program Supervisors (EPSs), Senior Education Program Specialists (SEPSs), Education Program Specialists (EPSs) II, and members of the Regional Research Committee (RRC) and Schools Division Research Committee (SDRC) including the Research Screening Committee (RSC). Participants are required to pre-register on or before July 6, 2021 through the link https://bit.ly/3ijBuKt.
- 4. The meeting link and access shall be provided a day prior to the conduct of the activity through emails and Facebook Messenger Group Chats. All participants are advised to utilize their deped.gov.ph email addresses to be able to access the MS Teams platform.
- 5. After this seminar-workshop, the Schools Division Office participants are expected to conduct a similar seminar-workshop to the School Heads and School Research Coordinators (SRCs)/Teacher-Representative per school in September 2021. The trained school participants shall subsequently conduct Learning Action Cell (LAC) sessions in any available platform
