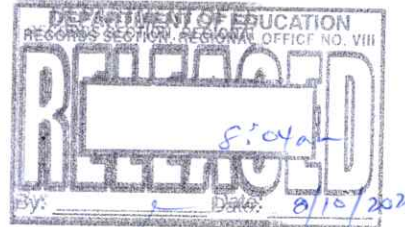

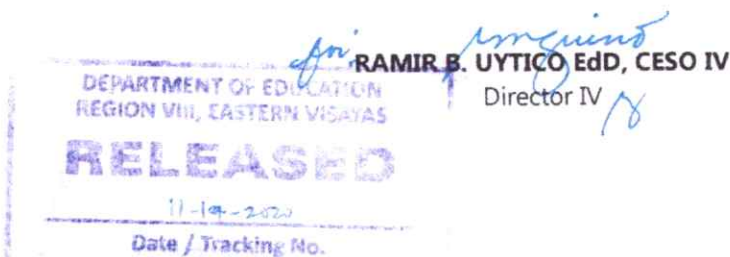



The Department of Education (DepEd) is committed to provide quality, accessible, relevant, and liberating basic education for all. DepEd had taken significant steps in addressing 21<sup>st</sup> Century Skills and requirements of the Industry Revolution 4.0.


In line with this, the Bureau of Learning Delivery-Teaching and Learning Division will conduct an Online National Workshop on the Revision of ICT for Teaching and Learning Framework and Policy Guidelines and Orientation. The activity which will be held on December 1-5 & December 7-11, 2020 is a part of the series of activities of Leveling up ICT Competencies through ICT-enabled Teaching (LICIT).

In this activity, the participants are expected to:

1. review essential learning theories for technology integration and good practices, policies in ICT Integration for possible incorporation in the draft framework;
2. develop technology integration planning model for effective ICT-enabled teaching and learning; and
3. revise the draft ICT-enabled teaching and learning framework and guidelines.

Attached are the program of activities (Enclosure A) and the expected participants (Enclosure B).

Participants are expected to be at the opening program on December 1, 2020 at 8:00 in the morning and the closing program on December 11, 2020 at 12:00 noon.

They also need to attend the online meetings throughout the duration of the activity and to produce the expected output.

All expenses relative to the conduct of the activity shall be charged against 2020 BEC funds subject to usual accounting and auditing rules and regulations. If the activity falls on a weekend or holiday, the participants, trainers, and management staff in the said activities shall be entitled to service credits pursuant to DepEd Order (DO) No. 53, s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers and DO 19, s. 2011 entitled Granting of Vacation Service Credits to Teachers Implementing Drop-out Reduction Program (DORP) and Open High School Program (OHSP). Moreover, nonteaching staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission and Department of Budget and Management Joint Circular No.2, s. 2004 on Non-Monetary Remuneration for Overtime Services Rendered.

Training/workshop expenses of writers/participants including internet/communication expenses shall be downloaded to the concerned Regions from the 2020 BEC Funds. Regional offices are encouraged to download the funds to the respective divisions. In the event that the downloaded funds are not sufficient to cover the actual training/workshop expenses of the participants, the ROs/SDOs shall allow the participants to reimburse the remaining balance from the Region/Division/School MOOE or local funds, subject to the usual accounting and auditing rules and regulations.

The identification of participants should be based on the requirements articulated in Enclosure B and gender responsive. Gender responsive as defined by United Nations Development Programme is "outcomes that reflect an understanding of gender roles and inequalities and encourage equal participation, including equal and fair distribution of benefits." (UNDP, 2003) The regions should submit the list of their recommended participants to confirm their attendance to said event not later than November 13, 2020.
