

- The Philippine Folk Dance Society (PFDS) in partnership with the Cultural Center of the Philippines (CCP), the National Commission for Culture and the Arts (NCCA) and selected Local Government Units will conduct the 40th National Folk Dance Workshop Virtual Edition and 3rd Indak Pilipinas: Virtual Folkloric Dance Festival via Zoom, FB Live, and CCP YouTube Channel on August 04-05, 2021.
- 2. The activity aims to give teachers and students the opportunity to learn dance skills online and to watch, enjoy, and experience a virtual production of the cultural dance heritage of the Philippines.
- 3. The 2-day online show will feature eight (8) dance groups and companies. Part 1 will be about online dance sessions and lecture demonstrations and Part 2 will be about dance showcase and performances. The shows/workshops are presented in packages (see attached for details).
