1. Paragraphs 3 and 4 of Regional Memorandum No. 433, series 2021 shall be corrected into the following:

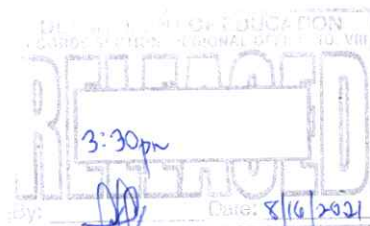
