CONDUCT OF THE VIRTUAL PROGRAM IMPLEMENTATION REVIEW (PIR) FOR THE INCLUSIVE EDUCATION (IE) PROGRAMS, SPECIAL CURRICULAR PROGRAMS (SCPs), AND OTHER SPECIAL INTEREST PROGRAMS (SIPs) AND ASSIGNMENTS

To: Schools Division Superintendents
Division Education Program Supervisors
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), shall conduct the Virtual Program Implementation Review (PIR) for Inclusive Education (IE) Programs, Special Curricular Programs (SCPs) and Other Special Interest Programs (SIPs) and Assignments on August 31 – September 3, 2021 via Zoom, Google Meet, or MS Teams.
2. The PIR aims to realize the following objectives:
 - a. conduct a more comprehensive review of relevant programs vis-à-vis their goals and objectives reflected in the implementation plans;
 - b. ensure participation of all Division Focal Persons/Coordinators during the entire duration of the activity of each IE, SCP, or SIP;
 - c. validate existing program data and gather missing data to close gaps in program implementation;
 - d. discuss issues, concerns, milestones, and future plans; and
 - e. promote teamwork, rapport, and friendly working relationships.
3. The participants to this activity are the Regional Education Program Supervisors and Personnel and their respective division counterparts consisting also of the Division Education Program Supervisors and Personnel handling a particular IE, SCP, or SIP. For IPEd, MEP, and SPFL, the school head and two (2) teachers per implementing school are requested to join the activity. The said participants are expected to register online at <https://bit.ly/PIR-Registration> not later than August 27, 2021.
4. As the success of the PIR is partly dependent on the attendance of the identified participants, the Schools Division Superintendents shall ensure the full participation of all the division program coordinators or focal persons. In the event that a participant is



unable to attend due to unavoidable circumstances, he or she may be represented by the CID Chief, or a substitute who is qualified, knowledgeable, and authorized to speak in behalf of the current program implementation.

5. The Division Coordinators, moreover, are directed to coordinate closely with their respective Regional Focal Persons as to data, report, or documents that they need to prepare or present ahead of time and consider backup measures for a virtual engagement. The slide decks and/or audio-video presentations should be forwarded to the concerned Regional Focal Person two (2) days before the scheduled activity.

6. To guarantee a smooth conduct and better focus on the PIR, separate schedules for the IE, SCP, and SIP sessions, reflected in Enclosure A, have been identified.

7. All expenses that may be incurred by the participants because of their involvement to this activity may be charged to local funds, program support funds, or other applicable sources of funds, subject to availability and to the existing accounting and auditing rules and regulations.

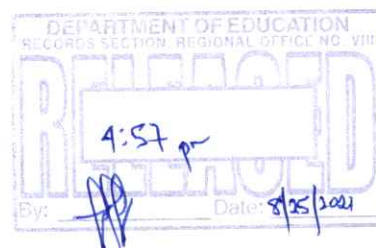
