VIRTUAL QUALITY ASSURANCE OF THE DEVELOPED PARENTS' TEACHING GUIDES (PTGs)/SPED SELF-LEARNING MODULES (SLMs) BY THE CORE LEARNING RESOURCE EVALUATORS (LREs) IN SPECIAL EDUCATION

To: Schools Division Superintendents
Division SPED Coordinators
All Others Concerned

- 1. In order to sustain the gains and address issues in the provision of quality learning resources to learners with special needs, this Office, through the Curriculum and Learning Management Division, shall conduct the Virtual Quality Assurance of the Developed Parents' Teaching Guides(PTGs)/Special Education (SPED) Self-Learning Modules (SLMs) by the Core Learning Resource Evaluators (LREs) in Special Education on September 29-30, 2021.
- 2. The main participants to this activity are the Division SPED Supervisor and five (5) SPED PTG/SPED SLM writers assigned in the elementary grades who shall be designated as the Core LREs in SPED in each Schools Division. Other participants, such as those from the Regional Management Team, shall spearhead the activity and shall take responsibility of logistics and documentation.
- 3. The regional activity aims to realize the following objectives:
 - a. capacitate and equip the PTG/SPED SLM writers with the skills necessary in the quality assurance of relevant SPED learning resources;
 - b. orient the participants with the proper standards on the quality assurance of LRs;
 - c. ensure that the developed LRs also observe the established social content guidelines; and
 - d. establish a pool of LREs in SPED who can led related activities on LR development in their respective Divisions.
- 4. The Division SPED Supervisors are tasked to identify their participants using the template which appears in Enclosure A and submit the same to the clmd.region8@deped.gov.ph or to the official messenger of the SPED supervisors of the Region not later than September 27, 2021.



- 5. The PTG/SLM writers are likewise directed to select and prepare the digital copy of one PTG or SLM that they have developed which shall be used during the workshop.
- 6. All expenses that may be incurred by the Regional Management Team shall be charged to the Regional SPED Program Support Funds (PSF) while expenses incurred by the Division participants shall also be charged to their SPED PSF or MOOE, subject to availability and the applicable auditing rules and regulations.
- 7. Immediate dissemination of and compliance with this Memorandum are desired.
