

CHAPTER I

INTRODUCTION

Education is believed to be an instrument of life's transformation. To a Filipino citizen, to be educated is a status symbol. In line with this condition, he needs to undergo a formal schooling within the four walls of a classroom.

In Talalora, a dream of having a secondary school was a journey. Theoretically, an estimate of twenty one years prior to its making as a municipality, a junior high school was established under the jurisdiction of the municipal officials, named *Talalora Municipal High School*, a two-year course offering which catered not only students from the municipality of Talalora but as well as nearby barangays of Daram, Samar and some transferees from other schools outside the region. Teachers were given a monthly honoraria from the municipal treasury, as students were paying minimal fees. Under the supervision of Miss Basilisa Duran and Mr. Genis N. Geli as the Assistant Principal, the school did not run that far due to some conflicts between the school management and the local officials hence, it was renamed as *Imelda High School* in honor after the Philippine First Lady. In the same manner students paid a monthly fee to defray for teachers compensation.

For some inevitable circumstances the school system was closed which eventually reopened in 1973 as *Independencia Barangay High School*, wherein the pioneering school head was Mr. Genis N. Geli. The school must have to be situated in barangay Independencia, Talalora, Samar yet to unavailability of

land area, it remained inside the Bagong Lipunan Building also known as Marcos Type Building of Talalora Central Elementary School.

In its metamorphosis, year 1986, President Corazon Cojuanco Aquino became the first lady president of the Philippine Republic who influenced the House of Congress for the conversion of all barangay high schools to National High Schools as embodied in the Philippine Constitution, students became liberated from paying their monthly tuition while teachers received equal standard salary from the national government too as the school bears now the name *Independencia National High School* from 1991 to present.

In School Year 2012 – 2013, the enhanced curriculum for K-12 was implemented under RA 105333, leading to offer Senior High School with two (2) strands: General Academics, TVL with two (2) majors namely Cookery and EIM where the school had successfully accomplished graduates under the K-12 program for four (4) consecutive academic years.

From its quick, yet long way history of the school, it needs to be renamed as **TALALORA NATIONAL HIGH SCHOOL** as the proposed name of the school since the school is situated within the town proper.

STATEMENT OF THE PROBLEM

Specifically, it sought to answer the following questions:

- 1. Why is there a necessity to change the name Indpendencia National High School?
- 2. What factors affect the changing of the name from Independencia

 National High School to Talalora National High School?

3. How does the name of the school improve the delivery of learnings to the clienteles?

A child's imagination is allowed to run its course, instead of being guided to think in a certain way.

Learning begins immediately after a child is born. Early education provided by pre-school programs can help to provide a solid and consistent educational foundation. From there, the child will join a senior school, where their learning will continue. By the time a child is joining college, they have already acquired vital skills, which will help them in all aspects of their lives.

LITERATURE REVIEW

Scot (1999) agrees that the survival of many schools depend to a great extent on their capacity to retain current students and recruit new ones, their mobilization of resources, achievement of their students, and their success in making their programs attractive to the external environment. He therefore considered marketing strategies to be an indispensable managerial function if they are to survive in competition environment. Sharrock (2000) argues that it is not enough for a school to be effective; it must also project an effective image to parents and stakeholders. Bowen et al. (2012) undertake a study to determine marketing strategies that attract and increase student enrollment in private universities in Kenya. Descriptive research design was adopted in

the study. Probabilitysimple random sampling technique was used to obtain a sample of 98 continuing undergraduate students and 28 employees from two private universities. A questionnaire was used as the research instrument and the obtained data were subjected to quantitative analysis. The findings indicated that advertising using an institution web site, advertising using the various media stations, use of social networks such as face-book, encouraging word-of-mouth, career fair involvement, open day on campus and alumni support are marketing strategies that can offer opportunity to attract and increase enrollment of students.

Kotler and Fox (1985) suggested that adopting marketing strategies would be an effective tool to overcoming decline in student's enrolment. The scholars maintained that schools that fail to think strategically about their marketing to portray the values of their institutions to be public often find themselves struggling with a range of issues such as poor enrolment, shrinking operating budget and image confusion. They suggested some marketing strategies that schools can use such as word of mouth, effective use of school website/social media, customization, pricing, adequacy of infrastructure, and advertising. Private secondary schools must explore a variety of marketing strategies as a way of communicating and convincing old and prospective customers (parents, students and stakeholders) that their school is the right choice.

One of the best ways to realize increase school enrolment is to run such an excellent operation, that parents and students will be very satisfied with the academic programmes and the impact will be seen in students' high academic achievement. In other words, it is operating the school business at a higher level than the regular school organization norms and effectively communicating the improvement to customers (Oplatka, 2006).

Michael (2003) takes a similar position by emphasizing the need to do something special to get people talking about your business. Products or services must be appealing and desirable for word of mouth marketing to be effective. This means that the services offered by private secondary schools should be one that is worth telling. Kotler and Keller (2009) states three noteworthy characteristics of word of mouth as a means of awareness or marketing a business: the first being that it is credible because people trust others they know and respect, secondly word of mouth may be a very intimate dialogue that reflect personal facts, opinion and experiences and it occurs when people want it to and when they are most interested, and it often follows noteworthy or meaningful events or experiences of customers.

Omboi and Mutali (2011) states that a well-executed direct advertising campaign can offer a positive return on investment through increased student enrolment. They maintained that direct advertising communicates the product offers, service, or event; and explains how to get the offered product, service, or event. This tool utilizes email, mail, catalogues, encourage direct responses to radio and TV, in order to reach targeted audiences to increase sales and test new products and alternate marketing tactics. Television is generally acknowledged as the most powerful advertising medium and reaches a broad spectrum of consumer, however needs to be adopted by educational institutions in reaching their target prospects and enrollees. Advertising has two particularly important strengths; first it can be an effective means of vividly demonstrating product attributes such as; school

facilities, buildings, computer laboratory, science laboratories, libraries, sports equipment, school uniform, etc. Secondly, it can dramatically portray user and usage imagery, brand personalities and other intangibles Kotler and Keller (2009). Advertising can be carried out through the media like newspaper, internet, and direct mails. Private school can us these mediums to reach prospective customers. Other outdoor advertising such as billboards and road shows can also be effectively utilized.

A well designed school environment, modern equipment and infrastructures can also serve as a strategy to attract patronage in terms of students' enrolment to institutions. Kotler and Fox (1985) believe that the first image in the mind of a parent/student will be shaped by this factor. Though appearances can be deceptive, the look of the school plant and its equipment create important first impressions of the school. The degree input is made in school environment to put up the structures and provision of teaching learning equipment will serve to determine the cost at which the education is provided. It is also a determinant of parents' willingness on how much to pay for the educational services. Onyemaechi (2013) states that price is the amount buyer pays for the service provide and to a large extent influence students enrolment. The price parents are willing to pay for the services offered needs to be affordable and commensurate with the educational services provided.

The use of websites and social media are contemporary means of advert and is seen as an effective way to portray organizational image to the world. It is however, a marketing strategy that is mainly needed in educational institutions in this global age. According to Rayport and Jaworski (2001)

companies must design websites that embody or express their purpose, product and vision.

They argued that often, the first move of someone who doesn't know about an organization will be to visit its website. This is reason why private secondary schools should maintain a web site and actively involved in social media interaction at all times. Scot (1999) opined that an effective educational marketing website needs to capture critical customer information such as the products and services offered by a school. Kennedy (2014) also noted that the target parents of today belongs to a generation that is active in the use of social media. Social media he argues is easily shared. When it is well done consistently can strengthen value in the mind of the target audience and will improve enrolment. Some of the most suitable social media that could be adopted by educational institutions as a marketing means include Facebook, Instagram, WhatsApp, Twitter, You Tube, Messengers, etc. The relevance of marketing strategy application cannot be overlooked if educational institutions must create impression that they are the best, which will facilitate customer attraction for them. Broadcast of important programmes, quality of programmes, beautified school environ, sufficient modern teaching equipment, social networking and school website will serve the purpose of attracting vast audience and prospects to facilitate number of enrolment.

CHAPTER II

Marketing Strategy to Increase Enrollment

The enrollment procedures in public schools combine all activities involved in the entire enrollment process following guidelines issued by several authorities. Due to current health situation, this might happen both online and offline, either in public or in private school, but the overall objective is to help our learners be admitted and enrolled in schools.

The marketing team launch the following strategy to enhance the enrollment procedure in our school in time of pandemic:

- 1. Publishing animated modified enrollment procedure Using vernacular language this video presented the procedure on how to enroll their learners, they have five options to enroll their child: a. they can enroll via text; b. they can enroll via call; c. they can enroll online; d. they can enroll offline; and e. drop-boxes they can go to their barangay offices to fill-up and submit the form.
- 2. Brigada Eskwela and Oplan Balik-Eskwela A program of DepEd (Department of Education) which aims to address resource gaps faced by the Department through strengthening partnerships with the local communities. The program mobilizes and brings together thousands of parents, alumni, civic groups, local businesses, non-government organizations, teachers, students, and individuals who volunteer their time and skills to do classroom repairs, maintenance work, and clean-up of public elementary and secondary schools. Given the positive result of the program, in 2008, it has become a permanent activity in the school calendar where all schools nationwide are mandated to implement the program weeks before the school opening. In times of

this pandemic we conducted our BE and OBE Program virtually to prevent the spread of this deadly virus.

- 3. Barangay Public Address partnering with the local government to advertise and encourage learners to pursue their education in our school. Using this bandelyo (trumpet) we can deliver directly the important school announcement to the community.
- **4.** Website sooner we will launch our very own school management system. These system connects schools and parents directly. It informs the parents about their children's development and learning progress without having to wait until the end of the semester or the occasional parents' conference.

Strategic Directions

Since Independencia National High School, to be renamed to Talalora National High School, is already established we will present the strategic direction of our school. Our school has clear and well-defined directions through its long term goal statements, key results area (performance goals), sectoral outcomes and sub-sectoral outcomes. CHAPTER V

Financial Aspect

In the rationale stipulated in DepEd Order No. 8, s.2019, the school budget is one of the most powerful tools to promote and strengthen the school based management and accountability. This is why apart from curricular reforms and capacity building programs, the Department of Education (DepEd) continues to make more resources available to schools to support them in enabling students to perform better. With the adoption of the new school Maintenance and Other Operating Expenses (MOOE) formula starting 2013, and the passage of Republic Act No. 10533 or the Enhanced Basic Education Act of 2013 expanding the basic education system from a 10-year to 13-year program with the addition of one year of Kindergarten and two years of Senior High School (SHS), the DepEd moves closer to rationalizing the programming of school budgets. Previously, the school MOOE budget was computed solely based on enrollment given a per capita cost. With the new formula, other factors affecting school operations are considered, such as the

number of teachers and classrooms managed by the school, the number of graduating or completing students, and a fixed amount corresponding to basic needs of a school. In addition to this, starting 2016, financial assistance previously released separately for special programs or activities are now incorporated in the budget for the operations of schools. The funds that will no longer be downloaded from the Central Office and are now part of the regular school MOOE budget include: a) financial assistance to support special curricular programs in Science (Special Science Elementary Schools, Regional Science High Schools, Science, Technology and Engineering Program in High Schools), Sports (High Schools with Special Programs in Sports), Arts (High Schools with Special Programs in Arts) and Special Education; b) DepEd Internet Connectivity Program; c) Gulayan sa Paaralan; and d) School Based Management Grants. The Department continues to develop and institute policies and reforms that would deepen the decentralization of education management.

The School MOOE has the following legal bases: The Department of Budget and Management (DBM) and DepEd Joint Circular No. 2004-1 dated January 01, 2004 entitled Guidelines on the Direct Release of Funds to DepEd-Regional Offices and Implementing Units; Section 10, Republic Act No. 9155 (Governance of Basic Education Act of 2001) which provides that the regional field offices appropriations intended for the and (elementary/secondary schools and schools division offices) are to be allocated directly and released immediately by the DBM to the said offices; and Section 11, Republic Act No. 10533 or the Enhanced Basic Education Act of 2013, which provides that appropriations for the operationalization of the enhanced basic education be included in the Department's budget. It is stipulated in the same DepEd Order that it is understood that the school MOOE funds shall be valid for release and obligation for one fiscal year: that is from January 1 to December 31.

The said legal document mandates that the non-IUs, including Independencia National High School, that do not have their own financial staff shall receive allocations of school MOOE from their respective SDOs in the form of cash advance. Therefore, the MDS Sub-Account/s of SDOs shall cover transactions of the SDO (Proper) including that of non-IU schools. The said fund is allocated for the following reasons:

- a. To fund activities as identified in the approved School Improvement Plan (SIP), for implementation in the current year, and as specifically determined in the Annual Implementation Plan of the school;
- b. To augment the expenses needed in the printing of modules under the Basic Education-Learning Continuity Plan amid the ongoing health crisis/COVID 19-pandemic. The said fund will also be used for the development of home learning guides, personal protective equipment. Production and distribution of Information. Education, and Communication (IEC) collaterals to promote minimum health standards, maintenance of respiratory and hand hygiene/WASH, rehabilitation of water and sanitation facilities and minor improvements in classrooms for proper ventilation, and other expenses as stipulated on DepEd Order No.15 s.2020

- c. To support expenses for training activities that are selected or designed based on the most critical needs to improve learning outcomes in the school;
- d. To pay for expenses for utilities and communications (e.g. electric, water and telephone expenses);
- e. To procure school supplies necessary in classroom teaching;
- f. To finance expenses pertaining to graduation rites, not to exceed a cost of PhP250 per graduating student;
- g. To pay for wages of janitorial and security services; and
- h. To fund minor school repairs.

The INHS is still following the cash advance scheme since there is no bank established or operating within the locality, thereby making the claiming of cash advance from the SDO safer, more practical, and more convenient. This is allowed and justified under DepEd Order No. 20 s.2019 titled Procedural Guidelines in the Management of Cash Advances for School Maintenance and Other Operating Expenses and Program funds of Non-IUs pursuant to COA, DBM, and DepEd Joint Circular No. 2019-1.

As of Fiscal Year 2021, the INHS receives a quarterly MOOE of Php 328,500.00. Therefore, the school has an allotment of Php 1,314,000 in this year. This is a slight increase from the school's previous allocation in FY 2020 which amounted to 326,562 quarterly and 1,306,248 yearly. All the funds allocated in the previous Fiscal Year have been fully utilized and obligated as of January 1, 2021.

CHAPTER VI

Socio-Economic Aspect

Resources invested in improving the quality of public education should be viewed as more than current expenditures for schools and the students attending them. Such expenditures are long-term investments in strong families, a strong labor force, and strong communities. Education serves a vitally important role in granting access to the information and skills needed by individuals to participate in higher education, to sustain productive employment, and to make effective choices about crime, health care, and civic participation.

In these ways, quality schools produce strong individuals and thus help families and communities to remain strong. In contrast, struggling schools are often associated with struggling communities and high levels of unemployment, crime, illness, and social alienation. Low-wealth communities lack the resources to support quality schools on their own, thus creating a cycle of social and economic disadvantage that is hard to break without investment and technical assistance from the state.

All Talaloranhons benefit from effective public schools. And we all pay the price for educational failure, including the social and economic costs of unemployment, shrinking job opportunities, rising crime, civic distrust, and high taxes needed to pay for health care and public assistance for low-income families. The question is whether we will muster the political will needed to invest in quality schools for children in all communities, or whether we will continue to look the other way as hundreds of thousands of children remain caught in the community-school cycle of inequality.

The executive and legislative branches of Local Government Unit make choices every year about the level of resources to extend resources in public education and how to distribute this funding to school districts. The future social and economic well-being of our town will benefit if these choices are based, not on politics, but on objective evidence about where educational investment will have the greatest return. This means that the government must establish a system for funding public education that provides for adequacy, equity, accountability, predictability, and efficiency.



SITE DEVELOPMENT PLAN


A Site Development Plan depicts the general layout and configuration of a site, including building footprints, parking and street layout, conceptual landscaping and lighting, site cross section drawings, and building elevations. The intent of the Site Development Plan is to depict the proposed site layout for the benefit of the public.

The Independencia National High School is located at Barangay Poblacion II, Talalora, Samar. It is a government/public national high school that offers both Junior and Senior High School. It is specifically situated in Domingo Street of the said municipality. In 2018, a site development plan was made by then principal of the school, Mr. Arturo G. Hermo. There are 14 academic classrooms, including two science classrooms of the Junior High department, while the senior high is situated in the elementary since the high school is sharing the same land area. The ownership of the said land area is under Tax Declaration No. CAD-401.

The said plan also illustrates the stage constructed in 2019, the flag pole which adjacent to the stage, the basketball court, and the Principal's Office. Indicated there are three proposed buildings, one next to the Senior High building which is now occupied by the TVL track, and the other two are situated in the rock garden. Academic Room No.9 is the faculty room and No.10 is the computer room.
