

- 1. Relative to the DepEd Memorandum No. 24, s. 2013 and DepEd Order No. 57, s. 2015, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a Re-orientation on the Utilization of the Early Grades Reading Assessment (EGRA) Tools on September 29-30, 2021 via Zoom.
- 2. The activity aims to:
 - a. re-orient the teachers in the first key stage on the utilization of the EGRA tools;
 - b. simulate the proper administration of the tools;
 - c. walk-through on the data recording and reporting templates;
 - d. agree on data analysis and submission procedure;
 - e. share division reading initiatives in the new normal;
 - f. address other issues, gaps, and concerns related to the early grades reading.
- 3. The participants to the activity are the CLMD OIC-Chief, Regional MTB-MLE Program Coordinator, Regional Supervisors in Filipino and English, Division Kindergarten and MTB-MLE Program Focal Persons, five (5) teachers in each of the grade levels from Kindergarten to Grade 3, and other CLMD staff as support group.
- 4. Each schools division is requested to prepare a 5 to 10-minute report (slide decks or audio-video presentation) on the reading/literacy initiatives in the first key stage implemented in the new normal specifically in School Year 2020-2021. The report may also include issues and challenges encountered with interventions and/or recommendations.
- 5. The concerned participants are expected to pre-register online on or before September 21, 2021. The links to the pre-registration, activity proper, and the attendance and evaluation forms shall be shared to the Division MTB-MLE Coordinators through the Facebook messenger.
