DOWNLOADING OF THE REMAINING ALTERNATIVE LEARNING SYSTEM (ALS) PROGRAM SUPPORT FUNDS (PSF) IN FISCAL YEAR 2020 TO THE SCHOOLS DIVISION OFFICE OF MAASIN CITY

- 1. In support to the pilot implementation of the **Basic Education Entrepreneurship Program (BEEP)** for the Alternative Learning System (ALS) in Region VIII and in light with the Republic Act No. 10679 known as the Youth Entrepreneurship Act, this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download funds amounting to Three Hundred Forty Thousand Pesos (**Php340,000.00**) to the Schools Division Office of Maasin City, Government Center, Combado, Maasin City, Southern Leyte.
- 2. The source of funds shall be taken from the savings of the 2020 Program Support Funds for the ALS.
- 3. The above-mentioned funds shall be used to cover expenses incurred in the reproduction of learning materials, development and production of advocacy materials, and conduct of meetings/orientations relative to the implementation of the BEEP Program.
- 4. The Schools Division Superintendent concerned, through the Chief of the Curriculum Implementation Division, shall submit a financial report on the utilization of the downloaded fund at least a week after the implementation to clmd.region8@deped.gov.ph cc alfredo.cafe@deped.gov.ph.

Further, there shall be a regional monitoring and technical assistance provision by the fourth quarter, through any authorized modality, to check the status of the previous downloaded funds intended for the ALS Program implementation in order to enhance the absorptive capacity of the Schools Division Office and to ensure successful pilot implementation of the BEEP Program.
- 6. All expenses incurred during the conduct of the regional monitoring shall be charged against the downloaded 2021 Program Support Funds for the ALS.
- 7. Immediate dissemination of and compliance with this Memorandum are desired.
