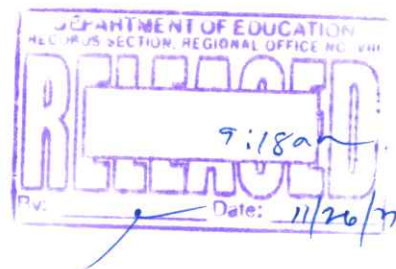

 - 3.1. prepare an implementation plan for the conduct of limited face-to-face classes in support of pilot schools in their respective jurisdiction;
 - 3.2. mobilize resources to meet the standards of the health and safety protocols;
 - 3.3. plan for the orientation of key officials on the standards and process of pilot implementation of face-to-face classes;
 - 3.4. conduct training and technical assistance to ensure that protocols and standards are met prior to opening of schools for face-to-face classes; and
 - 3.5. ensure that schools are linked to appropriate government agencies for the establishment of their respective referral system.
 - 3.6. provide technical assistance to the SDO thru the RO IPed focal person in preparing for and during the facilitation of the FPIC process; and
