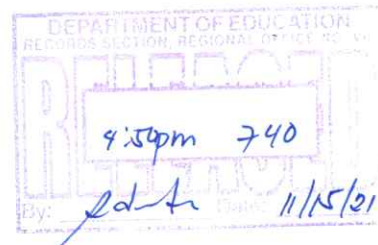

Republic Act (RA) No. 10922 or the Economic and Financial Literacy Act declares every second week of November as Economic and Financial Literacy Week (EFLW). Under the law, the National Economic and Development Authority (NEDA) is mandated to lead the celebration of the EFLW by coordinating activities that promote and improve economic and financial literacy among the public.
