VIRTUAL CONSULTATIVE MEETING CUM UPDATING OF THE DEPED PARTNERSHIPS DATABASE SYSTEM (DPDS)

- 1. To improve organizational accessibility to data and to help the end users share the data quickly and effectively across the organization, the DepEd External Partnerships Service started with the DepEd Partnerships Database System (DPDS) several years ago. However, to date, the system has been undergoing a lot of revisions and improvements. This has been posing a challenge in the updating of the entries in the system by the schools. Thus, this Region, through the Education Support Services Division (ESSD) shall conduct a Virtual Consultative Meeting cum Updating of the DPDS on December 13, 2021. The link shall be communicated to the participants on the day of the conference.
- 2. The objectives of the activity are to help the stakeholders gain access to partnerships data in the region faster and more accurate, and help produce higher quality information for faster, better partnerships decisions.
- 3. The participants to this activity are the ESSD Chief, the SPSS Head, 1 Regional DRRM Coordinator, 9 other ESSD Personnel, and 13 Division Partnership Focal Persons.
- 4. There shall be provision of food and necessary training materials for the Regional Office Personnel who shall be attending the activity face-to-face, charged to the RO fund covered by OSEC-8-21-4780, subject to the usual government rules and accounting regulations.
