Original copies of the Philgeps Registration Certificate (Platinum Membership), SEC/DTI/CDA Registration Certificate, Mayor's or Business Permit, Tax Clearance, Audited Financial Statements. **DOLE Certificate of Registration** and License to Operate from PNP-CSG-SOSIA may not be submitted on the date and the time of the bid submission. However, the bidder must be able to present such original copies during post-qualification on demand by the BAC or its authorized representative(s).

- That, under the Technical Specifications in Section II- Invitation to Bid, Section III- Bid Data Sheet – ITB Clause 19.3, Section VII- Schedule of Requirements, and Section VIII-Technical Specifications, the following technical specification shall be added:
  - "Must comply with DOLE Standards for payment of salaries and wages and other benefits."
- 3. That, in the Bid Data Sheet ITB Clause 20, the following documents shall be additional requirements during post-qualification:

3.1. Certificate of Registration issued by DOLE, and

3.2.License to Operate (LTO) issued by Philippine National Police-Civil Security Group-Supervisory Office for Security and Investigation Agencies (PNP-CSG-SOSIA)
