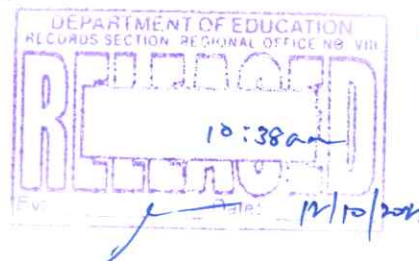

1. To ensure smooth implementation of Homeschooling as an Alternative Delivery Mode (ADM), the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) will conduct an Online Work Conference on Homeschooling on December 15-17, 2021 via Zoom.

2. The conference will be conducted to:

- a. Orient all schools division and regional personnel on homeschooling based on DepEd Order No. 21 s 2019;
- b. Map all the existing private schools with permit to offer homeschooling as an ADM;
- c. Map all learners enrolled in the homeschooling program; and
- d. Discuss issues and concerns on the implementation of ADM.

3. Each region is expected to send participants who have knowledge and are directly involved with the ADM and/or homeschooling and shall be composed of the following:

- a. One (1) CLMD Chief or his/her representative;
- b. One (1) Regional Education Program Supervisor in charge of ADM or his/her permanent alternate;
- c. One (1) Regional Personnel in charge of giving permit to private schools;
- d. Two (2) CID Chief or his/her representative;
- e. Two (2) Division Education Program Supervisor in charge of ADM; and
- f. Two (2) Division Personnel in charge of private schools. (Bring list of private school owners offering home school).

4. Participants are expected to 1.) attend all online plenary and break-out sessions; and 2.) conduct an orientation on homeschooling on their respective stations.

All regions through the regional ADM focal person and regional personnel in charge of the private schools shall prepare an initial report on the list of private schools granted permit to offer homeschooling as an ADM.
