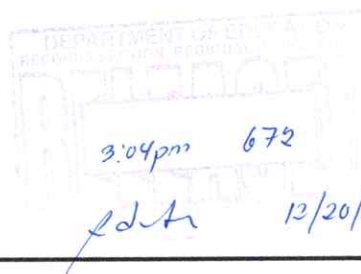

CONTEXTUALIZATION OF THE ADMINISTRATION SCRIPT AND SIMULATION VIDEO RECORDING OF THE COMPREHENSIVE RAPID LITERACY ASSESSMENT (CRLA)

To: Schools Division Superintendents
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a Contextualization of the Administration Script and Simulation Video Recording of the Comprehensive Rapid Literacy Assessment (CRLA) on December 15-16, 2021 and December 20-21, 2021, respectively at 9:00 to 4:00 p.m. via Zoom platform.
2. The participants to the contextualization of the CRLA administration script are the Regional MTB-MLE, English, and Filipino Learning Area Supervisors, the Regional Assessment Focal Person, and the 13 Division MTB-MLE Focal Persons with two (2) select teachers preferably those involved in the CRLA development.
3. Meanwhile, the participants to the simulation video recording are the following:
 - a. Waray – Rose Mhe D. Gaduena, Jaysson A. Alilita, and Roxane May Ropal; and
 - b. Inabaknon - Milen Esteria, Charito M. Bayabay, and Charmaine Saluib.
4. All the Schools Division Offices, through the Division MTB-MLE Focal Persons, are required to recommend two (2) teachers as part of the Regional CRLA Core Team and five (5) members of the Regional Training Team composed of the Division MTB-MLE Focal Persons and four (4) teachers handling Kindergarten and Grades 1, 2, and 3.
5. Moreover, the Division MTB-MLE Focal Persons are requested to submit the following data needed by the United Nations Children's Funds (UNICEF) not later than December 17, 2021:
 - a. Number of Grades 1 to 3 Learners per language;
 - b. Number of Teachers handling Grades 1-3 per language; and
 - c. Number of Schools with Grades 1-3.
