

Pursuant to DepEd Order No. 003, s. 2021 ("DO No. 03" for brevity), otherwise known as the "Creation of the Child Protection Unit and the Child Rights in Education Desk in the Department of Education," the Child Protection Unit (CPU), under the supervision of this Office, was mandated to "serve as the lead office of the Department in planning, implementing, coordinating, monitoring, and evaluating programs, projects and activities, including intervention mechanisms, related to child protection at different governance levels of the Department."²

Relatedly, under DO No. 03, the Education Support Services Division at the Regional Level, the Schools Governance and Operations Division at the Schools Division Office Level, and the Child Protection Committees at the School Level are the coordinating arms of the CPU for the planning, implementation, monitoring and evaluation, reporting, and coordination of child protection concerns.

In view of the foregoing, the CPU is requesting for the list of permanent focal persons and alternative representatives for ESSD and SGOD per region.
