The Office shall conduct emergency procurement of essential supplies and relief goods worth **Four Hundred Thousand Pesos (Php 400, 000.00)** to be given to the affected teaching and non-teaching personnel in identified hardly hit areas in Leyte, Maasin City, and Southern Leyte. The Office will also download financial assistance to the 3 affected Schools Division Offices to augment their local funds for repair which will be charge to ORD funds subject to the usual accounting and auditing rules and regulations. Below is the allocated funds per identified division:
