REGIONAL VALIDATION OF DIVISION ENTRIES FOR BRIGADA ESKWELA 2021 BEST IMPLEMENTING SCHOOL AWARDS

Schools Division Superintendents To: Regional Division Office Chiefs

All Others Concerned

- Pursuant to DepEd Memorandum No. 048, s. 2021, otherwise known as 2021 Brigada Eskwela Implementing Guidelines, all schools were mandated to conduct Brigada Eskwela (BE) implementation in schools from August 3 to September 30, 2021, focusing on collaboration and strengthening partnership engagements that complement DepEd efforts to implement the Basic Education Learning Continuity Plan (BE-LCP) and to ensure the delivery of quality basic education amidst the COVID-19 pandemic.
- As mandated in the said guidelines, all governance levels from the Division, Region, 2. and National levels are enjoined to recognize the best BE implementing schools. This Region shall conduct its Regional Awarding Ceremony tentatively on March 30, 2022.
- Relative to this, the following regional validation teams shall conduct the validation of 3. Schools Division entries from February 14-18, 2022, and February 21-25, 2022. The regional validators shall coordinate with the respective assigned Schools Division Offices (SDOs) on the actual date of visit, for the SDOs to be able to provide the necessary logistics:
