1. Paragraphs 1 and 2 of Office Memorandum No. 098 dated February 21, 2022 are hereby corrected as follows:

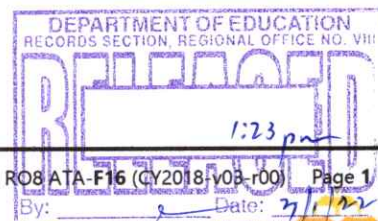
