



### **CONCEPT NOTE**

#### 1. Background

UNESCO supports the Philippine Government through the Department of Education in its Alternative Learning System (ALS) Programme with the implementation of the "Better Life for Out-of-School Girls to Fight Poverty and Injustice in the Philippines" Project with the overall goal of improving quality of life for girls living in poverty particularly supporting out-of-school girls registered in ALS for their further education opportunities or future job chances. The project is envisioned to contribute in the attainment of Sustainable Development Goals (SDG) in particular SDG 4 in the Philippines with the generous financial assistance of the Korea International Cooperation Agency (KOICA).

The establishment of the Girls Education Centre located inside the compound of DepEd Regional Office VIII-Eastern Visayas, Government Centre, Brgy. Candahug in Palo, Leyte in the Philippines is a key component of the project. It is a one-stop educational hub where out-of-school girl-learners will be able to avail holistic support and opportunities to improve their lives through continuing learning and life skills training under ALS programme. Tacloban City and its vicinity including Palo in Leyte are the project's pilot areas.

Actual construction of the Girls Education Centre commenced in April 2021 with the official ground-breaking ceremony and thereafter construction of the GEC building is on-going. A slight delay was encountered in the construction due to the revision of the foundational structure of the building as a response to the significant challenge of a weak soil condition at the rear side of the GEC building site as a result further of the joint-sectional survey conducted of the site. With the final revision of the foundational structural design completed, the construction activities resumed in October 2021.

Under the contract with the engaged building contractor, VistaGreen, a monitoring and technical evaluation of the progress of the construction of the GEC building shall be undertaken in order to determine and confirm the 25% actual accomplishment of the construction as part of the initial evaluation. Together with UNESCO, the Department of Education through the Education Facilities Division's team as technical team support in the construction of GEC shall undertake the monitoring and technical evaluation of the progress of the on-going construction. This particular task will involve visit to the construction site and undertake actual check and then followed by a review and evaluation meeting between UNESCO and DepEd together with the building contractor. Further, after the initial evaluation, a subsequent technical review and evaluation will likewise be undertaken prior to the full completion of the GEC building.

#### 2. Objectives

The technical review and evaluation meeting aims to:

- 1) Check the progress of the on-going construction and determine the level of accomplishment based on the construction workplan and schedule of the Contractor;
- 2) Specify and indicate observations, technical points based on quality of work following the quality assurance measures and recommendations formed and developed from the actual site inspection and visit;
- Discuss the result of the actual site monitoring and progress check by the team involved and develop specific agreements in terms of carrying out recommended steps to be undertaken.

#### 3. Outcomes

The expected outcomes from the meeting are:

- 1) Levelling off the understanding on the actual physical accomplishment of the construction of the GEC building thus far and with clear field/ground understanding of the situation in the construction site;
- 2) Monitoring the actual physical accomplishments against the expected deliverables of the contractor based on agreed timelines;
- 3) Verifying and certifying the completion of the 25% accomplishment of the construction of the building;
- 4) Addressing issues and challenges encountered by the contractor in the on-going construction activities as part of the review and evaluation of the progress.
