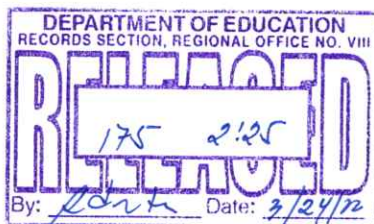

**CORRECTION OF SCHOOL NAME ON RECORDS OF

In reference to the approved Amended Articles of Incorporation by the Securities and Exchange Commission (SEC) with Company Registration No. 4281 of Saint Joseph College, Maasin, Leyte of Maasin City, Southern Leyte dated June 11, 2015, the Department of Education Regional Office No. VIII through the Quality Assurance Division (QAD) announces the correction of school name on records from **St. Joseph College- High School Department** in the issued Government Recognition on April 1, 2001 and **St. Joseph College** in the Enhanced Basic Education Information System (EBEIS) to **Saint Joseph College, Maasin, Leyte** effective March 23, 2022.
