

## Selection Criteria for Schools and Participants

#### Selection Criteria for Schools

• The schools should be able to commit to supporting their representatives (three to five individuals) who will be attending the training from March to May 2022.

## Selection Criteria for Participants

The individual should:

- have worked at the Department of Education in a teaching or non-teaching position for at least six months;
- commit to completing the training from 18 April to 08 July 2022 (4 to 6 hours a week);
- have access to stable internet connection and laptop/desktop computer; and
- have completed the Standardized DRRM modules (to be prioritized).

Note: For teaching personnel, the selection is NOT limited to Science teachers.
