

UPDATES ON THE CONDUCT OF THE REGIONAL QUALIFYING EVENT FOR ATHLETICS

- This Office, through the Curriculum and Learning Management Division (CLMD), announces the following additional details that shall be taken into consideration for guidance of the participants relative to the conduct of the Regional Qualifying Event for Athletics (RQEA) through DepEd Memorandum on the National Invitational Sports (NISC):
 - a. The schedule of the aforementioned event shall commence on May 19, 2022 at Ormoc City Superdome, Ormoc City with an opening program followed by solidarity meeting per attachment;
 - b. Accommodation for the division delegations shall start on May 17, 2022 in the assigned billeting quarters at Ormoc City Regional Sports Academy / Ormoc City Central School, Ormoc City;
 - c. The participants from each division delegation shall provide their own food and bring their own beddings, but mattresses shall be offered by the host division;
 - d. The promotional streamer/tarpaulin shall be prepared by each division delegation that will be brought during the motorcade or parade; and
 - e. The participants to this activity who travel or render services on days that fall on weekends and holidays can avail of the Service Credits, CTO or COG equivalent to eight (8) hours of service per day whichever is applicable per DepEd Order No. 67, s.1988 and CSC Memo Circular No. 09, s. 1988.
